CALL TO ORDER AND PLEDGE OF ALLEGIANCE:

Meeting was called to order at 6:00 pm by Rob Saunders.

APPROVAL OF AGENDA:

Kim makes motion to approve agenda. Larry seconds motion. Agenda was approved with all ayes. Motion carried.

APPROVAL OF MINUTES:

Larry asks for approval of the January 2023 minutes. Dustin Seconds Motion. Minutes were approved with all ayes. Motion carried.

APPROVAL OF BUDGETARY POSTING JOURNAL:

OLD BUSINESS:

CHIEF OF POLICE

Chief King gave brief update on hiring process. Application process has closed. 16 applications were received with several applicants having ILEA certification and experience. Physical agility testing scheduled for March 4 at BHS with interviews the following Monday and Tuesday.

NEW BUSINESS:

CHIEF OF POLICE

Chief King advised of an issue with Uniform Allowance Check issuance. One officer is in another departments hiring process. Check has been withheld at this point (due to no policy in place) until status with our department is known and commission can decide on next steps. Policy will be developed and brought to commission within the next month or two. Dustin made a motion to hold the check as long as officer has access to needed equipment until determination of outcome of hiring process is known. Larry seconded. 4 ayes, 1 nay, motion approved.

Chief King provided the commission with a revised spending plan for additional monies in 2023. Was given approval to order (2) 2023 Dodge Durangos (one from extra monies and one from insurance money) by town board president due to ordering window closing in the near future. Dept. is also going to rear positioned kennels for the K9 vehicles for both officer and K9 comfort and room.

Chief King requested approval from the commission to appoint a new reserve officer. April Hyde (retired Brownsburg PD officer) expressed her interest in becoming a Pittsboro PD reserve and would require very little effort to get ready to patrol. Dustin made a motion to appoint April Hyde as a PPD reserve officer, Kim seconded. Motion passed with all ayes.

CALLS FOR SERVICE:

Monthly Stats and K9 Stats were submitted to commission

ATTORNEY REPORT:

Marksberry spoke with the attorney representing the ILETB and needs to speak with 2 commissioners offline to apprise them of next steps going forward.


ADJOURNMENT:


