This would fall within Indiana Code for the fee and would bring us up to the standards of surrounding departments. This fee would be placed in the departments continuing education fund. Larry Compton made a motion to raise the fee to \$150 per video. Kim Shupert seconds. Motion passes with all ayes.

Chief King proposes to add a \$25 fee for impounded vehicle releases. This would be an administrative fee to cover time and supplies for the administrative assistant to provide release paperwork for impounded vehicles. This

fee would be placed in the departments continuing education fund. Larry Compton made a motion to add the \$25 fee to impounded vehicle releases. Dustin Danai seconded. Motion passed with all ayes.


ADJOURMENT:


