This included electric work in Spark's addition, drain lines and catch basins on N. Maple, Poplar and Wall St., replace gas main on N. Maple to Main St. and remove and replace Osborne Ave.

Mr. Hueber asked for an update on the safety issues pertaining to Scott Park. Shelby Smith said he would take the plan that was prepared by Jim Mardis and Christi Patterson to the Little League and report the actions to be taken at the April Meeting.
